ELEGIBILITY

BOTTOM-UP approximation (*multi-sectorial*)

- Evaluation in parallel (per company):
 - TECHNOLOGICAL
 - Technology and Innovation
 - Consortium capacity
 - Commercial and Exploitation Plan
 - Socioeconomic Impact, Gender Perspective and Sustainability
 - FINANCIAL
 - Risk analysis (the company is in crisis?)
 - Project economical-financing analysis
 - Company economical-financing analysis
 - Economical-financing adequation to the planned activities

Technology development is mandatory





FUNDING CONDITIONS

PROYECTOS DE COOPERACIÓN TECNOLÓGICA INTERNACIONAL funding line

International Innovative R&D Projects

- National Consortium led by a company
- Research Centers and Universities subcontracted
- Minimun fundable Budget: 175.000€
- Duration from 12 to 36 months
- Exploitation and Dissemination activities are not eligible for funding

Financing conditions for Innovative projects:

- Credits up to 75% (85% in regions co-funded with Technological Fund (TF)) (Euribor interest appliable only on reimbursable frame)
- 30% of the credit not reimbursable (SMEs), 25% (Large Companies)
- Multiannual funding (1-3 years)

Advance payment:

- 35% when contract is signed, limit 250k€, no aditional guarantees required
- If >= 50%, with guarantees



INTERNATIONAL LEVEL:

- Balanced consortium
- Countries with finantial availability
- A sub-consortium leader per country
- Technological Centres and Academia's role coherent with national funding application

NATIONAL LEVEL

- IMPORTANT: Emphasis on R&D activities
- Leadership recommended (Project, WPs, Tasks ...)
- Avoid overlapping with other presented projects
- Market, Gender Perspective included
